#### **1.0 INTRODUCTION:**

The National Institute for the empowerment of persons with Intellectual Disabilities(Divyangjan), popularly known as NIMH, was established in the year 1984 as an autonomous body under the Ministry of Social justice & Empowerment, Govt. of India. NIEPID has regional Centre at New Delhi, Mumbai and Kolkata.

The Objectives are:

- Human resource development
- Research and development
- Development models of care and rehabilitation
- Consultancy services to voluntary organizations
- Documentation and dissemination
- Extension and Outreach Programmes.

These objectives apart, NIEPID has developed service models and contributed very significantly in the dissemination and documentation. The performance in the extension of an out reachprogramme is excellence covering large area across the country. It is a "Vision", "Mission", and "Value" driven organization having work culture appropriate to higher education. The institute is a "Learning Organization". The institute's values extend to equal opportunity, participation of people and gender-just practices.

### **1.1 GENERAL OBJECTIVES OF THE COURSE:**

The Diploma course in Special Education aims to develop professionals for special education within a broad framework of education in the current millennium. The course will enable pre-service teachers to acquire knowledge, competencies and practice skills to impart education to children with special needs.

The general objective of the course is to prepare Special teachers at pre-primary (Nursery, Kindergarten etc.) and primary (1 to IV Lower primary and V to VII – Upper primary) levels to Serve in the following settings:

- 7) Individual and group parent interaction.

## **3.0 JOB OPPORTUNITIES:**

- **4.0 ELIGIBILITY:** Candidates who have passed 10+2 HSC examination passing with 50% marks are eligible for the course.

#### **6.0 SELECTION:**

Application for admission will be screened and short listed on the basis of three candidates per seat by the committee specially constituted for the purpose. Merit list will be prepared based on the academic qualification, weightage given for having child/sibling with mental retardation and interview. TA/DA will **not**be paid by the institute for attending the interview. No candidate is allowed to change the course of study once admitted and if he/she is still desirous to join course within the institute, the fee/deposits remitted to the institute shall be forfeited.

#### 7.0 JOINING AND SUBMISSION OF CERTIFICATES:

Selected candidates should join the course by the stipulated date. At the time of joining the course, the selected candidate will have to produce. (a) Undertaking to the effect that the admitted candidates will not discontinue the course and (b) Medical certificate of fitness from a Civil Surgeon / any Govt. hospital declaring the state of health.

#### 8.0 NUMBER OF SEATS: 30 + 03 (EWS)

Out of 30 seats, five seats are reserved for SC, two seats for ST, Eight seats for OBC and one seat for PH.

**9.0 DURATION:** The duration of the course will be 220 days consisting of 1320 hours each year thus having a total of 2640 hours for theory and practicum. (Two academic Year).

#### **10.0 MEDIUM OF INSTRUCTION:**

Delivery of lectures will be in English only. However, candidates will be allowed to write the final exam in Hindi, English and Bengali.

#### **11.0 ATTENDANCE:**

Minimum attendance of 80% is essential to be eligible for appearing for the examination. 10% attendance may be considered in case of illness on production of proper medical certificate. 100% of the practical work and assignments should be completed and certified by the respective faculty prior to the examination. However, the final decision of allowing for examination will be taken by the competent authority.

Any shortage of attendance will have to be made up before final examination by the student concerned and the institute does not take responsibility whatsoever in arranging theory and practical classes. The application of these candidates with shortage of attendance will not be considered for issue of hall ticket to appear in examination.

The institute reserves the right to cancel the admission if the candidate admitted found to be habitually absent or is not putting up the required attendance or is not making significant improvement in studies or not taking interest in pursuing the course of study.

The guidelines pertaining to examination procedures prescribed by the Rehabilitation council of India shall be adopted.

#### **12.0 EXAMINATION:**

There will be two terms examination at the end of each academic year, the trainees will have to appear in the final examination as well as internal and external.

#### **13.0** AWARD OF DIPLOMA:

Based on the performance during the course and on the annual examination, the successful candidates will be awarded Diploma in Vocational rehabilitation (Mental Retardation). Minimum marks of passing examinations will be 40% in each theory paper (internal and external separately) and practical paper will be 50% (internal and external separately). Candidates scoring 75% and above will be awarded the Diploma with Distinction.

#### **15.0 HOSTEL ACCOMODATION:**

Shared hostel accommodation to outstation candidates will be provided on nominal charge at NIEPID-RC, Kolkata subject to availability on first-come first-served basis. The trainees will have to bear the expenses on food by joining a student's run mess.

#### **16.0 DISCIPLINE:**

The candidate admitted should abide with discipline within the prescribed administrative regulation and also avail the hostel accommodation as provided. The candidates are expected to maintain decorum, decency and discipline throughout their pursuance of the course with the staff, faculty, co-students and other supporting staff. The hostellers should follow the prescribed rules and regulations. Any infringement of violence shall result in removal of the student from the hotel for the period as decided by the management of the institute.
