## ABOUT THE INSTITUTE:

The National Institute for the Empowerment of Persons with Intellectually Disabilities (NIEPID) (formerly NIMH), established in 1984 and personnel in different long-term programmes recognized by Rehabilitation Council of India (RCI). Long term face to face graduate and post Graduate programmes, and M.Phil Programmes are affiliated to different universities. NIEPID has organized many international and national conferences. In the Continuous Rehabilitation Education programmes, more than one lakh rehabilitation and health professionals, personnel and government officials have been trained. It has highly qualified faculty members and specialists from multi-disciplinary fields. NIEPID is the ISO Certified Organization with the following objectives.

## **M. Ed SE (ID) COURSE:**

Special Education is an emerging field. There is requirement of increased Human Resources in the field. With the Rights of Persons with Disabilities Act, 2016 mandating the right to education for every child with disability, the role of special educators has further been signified across life span needs for independent living and ensuring quality life.

Keeping in view the need for special education teachers/educators at various levels, master level programme i.e., the M. Ed Special Education (Intellectual Disabilities) course has been launched in affiliation to Osmania University with the approval from RCI. The course duration is made for 2 years (4 semesters) as per NCTE norms. In the current scenario, special educational services in the country consist of special schools, special classes in regular schools, inclusive schools and community based programmes. All special educational programmes require qualified human resource to deliver quality services in above educational settings. For this purpose qualified M.Ed Special Education (ID) professionals can serve as master trainers to teach special educators under going training at diploma or graduate levels in special education (ID).

### **Objectives**

On the completion of the course the student will be able

- i to function as teacher educator and faculty member at teacher training courses
- ii. to function as researchers in the field of disability rehabilitation and special education
- iii. to function as educational program planners in general, inclusive and special schools
- iv. to function as school administrators and program heads
- v. to function as curriculum developer

### **ELIGIBILITY FOR ADMISSION**

The admission for the degree of M.Ed. Spl.Edn (ID) degree shall be open to:

a) A candidate who has successfully passed B.Ed Spl. Ed.(ID) with minimum 50% marks from a recognized university or any other degree considered equivalent to B.Ed Spl. Ed (ID) from any university or teaching department under any university recognized by U.G.C and approved by RCI.

OR

b) A candidate who has successfully passed the B.Ed General course and has successfully completed Diploma in Education Special Education (ID) recognized by the RCI with minimum 50% marks in each course.

OR

c) A student with B.A./B.Sc./B.Com. having B.Ed.Spl.Ed. (4 years Integrated with a specialization in MR/ID) approved by the RCI

d) B.Ed Final year students who are appearing and awaiting results can also apply. The admission will be given only to those who will submit the passing certificate, marksheet/results at the time of admission counselling.

**A student with B.Ed. in particular specialization may be allowed for M.Ed. multi category but the reverse is not allowed. B.Ed. with multi-category should not be admitted for specialization in a single disability at the M.Ed. level.**

## **For Foreign Nationals**

**5 supernumerary seats are available for foreign students. There is no entrance examination conducted for foreign students. Students have to apply directly to the Director, University Foreign Relations Office, Osmania University after Osmania University advertises the courses in their website. The admission is given by the Osmania University directly on first come first served basis as per the eligibility criteria of the course.**

**The fees for the course is as per the Osmania fee structure for the course.**

### **Admission Procedure:**

A candidate for admission into M.Ed Special Education (ID) Course has to qualify in the Entrance Examination conducted by the Osmania University for that academic year. The candidates will be admitted strictly in accordance with the merit secured at the entrance examination, keeping in view the rules in force in respect of the statutory reservation of seats under various categories of candidates.

Admission is given on the basis of the merit obtained by the candidates in the entrance examination and followed by counseling / Interview conducted as per the rules and regulations of Osmania University. In case of tie in the rank, the order of merit will be decided on the following basis: 1) The candidate who secured higher percentage of marks in the qualifying examination gets the higher priority. 2) In case the percentage of marks in the qualifying examination is also tied, then the candidate who has more Age (below 35 years) gets the higher priority.

### **AGE:**

While no maximum age is prescribed, preference will be given to those below 35 years of age.

### **Health:**

Candidates are required to declare their health status in the application in case of pregnancy, infectious diseases, chronic health problems or suffering from any psychiatric problem. If the candidate is unable to complete course requirement due to health problems then NIEPID reserves the right for termination from admission to M.Ed Spl.Edn.(ID).

### **NUMBER OF SEATS: 25 + 2 EWS**

### **Reservation will be applied as per the rules of Government of India**

(Reservation for PH – Persons having disability only in lower limbs without reverse limitations in mobility may be considered for this category).

### **Duration of the Course: 2 years**

The Course/programme will be of 4 Semesters (two years) with 2 semesters in each year. Each semester will be of 16-18 weeks; 2 weeks in summer and 2 weeks in inter semester break will also be utilized for covering the courses. In this way, the following operational weeks will be available for transacting the course:

Year 1- 16-18 weeks for each of the two semesters + 2 weeks in summer

Year 2- 16-18 weeks for each of the two semesters + 2 weeks in inter-semester breaks

No admission / readmission is to be made after the expiry of four weeks from the date of commencement of instruction. In case there are any court cases consequent on which the Convener of admissions is compelled to admit any candidate after the last date of admission, the admission (seat) of such a student be reserved for the subsequent year on supernumerary basis.

Supplementary or any other examination (except internal tests) shall be conducted during the instruction period of the semester.

A candidate admitted to M.Ed Special Education (Intellectual Disability) course will forfeit seat and admission stands cancelled if;

He/she does not put in at least 40% of the attendance in Semester – I.

OR

He/she does not secure promotion to Semester-II within a maximum period of two academic years starting from the year of admission. The same system will be applicable for semester III and IV.

OR

He/she fails to fulfill all the requirements for the award of the degree as specified, within two academic years from the time of admission.

### **AWARD OF DEGREE:**

The M.Ed Special Education (Intellectual Disability) Degree in the Faculty of Education will be conferred on a candidate who has pursued a Regular Course of Study for two academic years as prescribed in the scheme of instruction and has passed all the examinations as prescribed in the scheme of examination.

### **WORKING DAYS & ATTENDANCE**

The programme will be conducted for at least 200 working days each year exclusive of the period of examination and admission. Physical presence in the institution of all the teachers and student teachers is necessary to ensure their availability for advice, guidance, dialogue and consultation as and when needed.

The minimum attendance of Student-Teachers shall have to be 80% for all course work, 90% for all practicum, and 100% for internship (10% attendance may be condoned by OU on health grounds).

Attendance at NCC/NSS Camps or Inter-Collegiate or inter-University or Inter-State or National or International Matches or Debates, Youth Festivals or Educational Excursions if they form part of the curriculum of such other Inter-University, Inter-College activities as approved by the University will not be counted as absence. However, the aggregate of all such absences should not exceed four weeks in a semester.

In any semester of the M.Ed Special Education (ID) course, if a candidate fails to secure the minimum percentage of attendance, he/she shall not be eligible to appear in the examination of that semester and he/she shall have to enroll himself/herself to undergo afresh a Regular Course of Study of the corresponding semester in a subsequent academic session in order to become eligible to appear for the examination.

Attendance shall be reckoned from the date of commencement of instruction as per the almanac communicated by the College/University. However, in the case of late admitted candidates (but within the stipulated time), the attendance will be reckoned from the date of admission.

To enable the students to know their attendance, at the end of each month the concerned Heads of Departments shall display cumulative attendance for information

### SCHOLARSHIPS:

- a. Central Government Scholarship for Top Class Education for SC / ST students. The SC / ST students should submit the documents of caste and income certificates at the time of admission itself to enable academic section to initiate forwarding application for Top Class education scheme with in two working weeks of admission, listed in guidelines by Ministry of Social Justice and Empowerment, New Delhi.
- b. State Government Scholarship for SC / ST / BC to be applied by the Individual students in the respective state government portals.

### MEDIUM OF INSTRUCTION AND EXAMINATION:

The medium of instruction and examination will be in English.

**Note:**

- 1- Other fees such as university registration, migration fee, student recognition fee, exam fee, student welfare fund, inter university tournament fee, academic record inspection fee etc. will be charged extra as prescribed by the Osmania University, Hyderabad after commencement of 1<sup>st</sup> semester / 1<sup>st</sup> year classes.
- 2- The Tuition fee will be waived off for Students with disabilities who are having UDID Cards, as well as for those who have Disability Certificate and have got enrolled on UDID portal, irrespective of percentage of Disability.

**ELIGIBILITY CERTIFICATE:** - Candidates admitted in the course have to submit Eligibility Certificate from Osmania University (students from other than Osmania University) within 15 days from date of joining. If the candidate fails to submit the same, the admission will be cancelled duly forfeiting the amount paid by them.

- ◆ **Original certificates deposited will not be released during the course and students are advised to keep sufficient number of photo copies before submission of original certificates to office at the time of admission.**
- ◆ **Procedure for acquiring bonafide certificate: Bonafide certificate will be provided if the student applies for the same to the Incharge, Academics**

The candidate once admitted in the course will not be allowed to leave the course under any circumstances. If the candidate still desires to leave the course for any reason, the total fee and deposits paid by the candidate will be forfeited.

## **HOSTEL ACCOMMODATION:**

Limited shared hostel accommodation is available and will be provided to outstation candidates on request on first-come-first-served basis at current nominal charge of Rs. 750/- per month towards electricity, water, room rent and maintenance services. The candidate admitted is required to pay Rs.1500/- as hostel deposit, which will be refunded at the end of the course, after deducting amounts for damages if any caused by the candidates. The students should follow all the hostel rules as notified at the time of admission into hostel. In case of violation of the hostel rules, the students will be expelled/suspended from the hostel.

## **DISCIPLINE:**

The candidates admitted shall be subjected to strict discipline inside and outside the campus and also in the hostel where accommodation is provided. The candidates are expected to maintain decorum, decency and discipline throughout their pursuance of the course with the staff, faculty and other supporting workers. The hostellers should follow the prescribed rules in the hostel. Infringement or violation of rules shall result in rustication from the hostel for a period as decided by the management of the Institute. Use of cell phones for personal reasons/entertainment during working hours is strictly prohibited.

Ragging is a crime prohibited under law. Anyone found indulging in the unethical act of ragging will be isolated/punished by management and law enforcing authorities as the case may be.

## **ENTRANCE EXAMINATION**

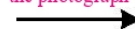
