**ABOUT THE INSTITUTE**: The National Institute for the Empowerment of Persons with Intellectual Disabilities (NIEPID) was established in 1984 under the Ministry of Social Justice and Empowerment, Government of India. It is an apex body to undertake human resource development for delivery of services to persons with Intellectual Disability, to develop appropriate models of care for persons with mental retardation, to identify, conduct and coordinate research in assessment, education, training and rehabilitation of persons with mental retardation and to serve as National Resource Centre in the field of mental retardation. The institute has its regional centres at New Delhi, Kolkata and Mumbai.

NIEPID Regional Centre, Kolkata was established in March, 1986 in the campus of National Institute for the Orthopedically Handicapped, Bonhooghly, B.T.Road, Kolkata- 700 090. The centre runs 3 long-term courses approved by RCI namely:

- B.Ed. Special Education (ID) (two-year duration)
- Diploma in Education (Special Education- ID) (two-year duration)
- Diploma in Vocational Rehabilitation (D.V.R. (ID)) (one-year duration)
- B.Ed SE DE (ID) under Netaji Subhash Open University

The centre conducts short term training programmes/ Seminars/ National Conferences for professionals and parents every year. Clinical Services available for early identification and intervention for overall development of the child at risk. Services in the areas of special education, vocational training and early intervention are provided in this centre.

Placement of students is allowed for undergraduate and postgraduate students from the areas related to the field of Intellectual Disability. The centre conducts awareness camps and screening camps as a part of its extension and outreach activity. The centre also provides technical support to NGOs working in the field of Intellectual Disability.

The institute endeavors to excel in building capacities to empower persons with Intellectual Disabilities. Since the quality of life of every person with Intellectual Disabilities is equal to other citizens in the country, in that they live independently to the maximum extent possible and through constant professional endeavors, National Institute for the Empowerment of Persons with Intellectual Disabilities (Formerly National Institute for the Mentally Handicapped) empowers the persons with intellectual disabilities to access the state of the art rehabilitation intervention viz., educational, therapeutic, vocational, employment, leisure and social activities, sports, cultural programmes and full participation.

### ABOUT THE COURSE AND ITS GENERAL OBJECTIVES:

Special Educationist an emerging field. There is requirement of increased Human Resources in the field. With the Rights of Persons with Disabilities Act, 2016 mandating the right to education for every child with disability, the role of special educators has further been signified across life spanned for independent living and ensuring quality life.

Keeging view the need for special education teachers/educators at various levels, master level programme i.e., the M. Ed Special Education (Intellectual Disabilities) course has been launched in affiliation to West Bengal State University with the approval from RCI. The course duration is made for 2years (4 semesters). In the current scenario, special educational services in the country consist of special schools ,special classes in regular schools, inclusive chools and community based programmes . All special educational programme required qualified human resource eto deliver quality services in above educational settings . For this purpose qualified M.Ed Special Education (ID) professionals can serve as master trainers to teach special educators undergoingtrainingatdiplomaorgraduatelevelsinspecialeducation(ID).

#### **ELIGIBILITY:**

The admission for the degree of M.Ed.Spl.Edn (ID )degree shall be open to:

- A student with B.Ed. in particular specialization may be allowed for M.Ed. multi category but the reverse is not allowed. B.Ed. with multi-category should not be admitted for specialization in a single disability at the M.Ed.level.
- A student with B.A./B.Sc./B.Com. having B.Ed.SpI.Ed. (4 years Integrated with a specialization in MR/ID )approvedbytheRCI

## AdmissionProcedure:

A candidate for admission into M.Ed Special Education (ID) Course has to qualify in the Entrance Examination for that academic year. The candidates will be admitted strictly in accordance with the merit secured at the entrance examination, keeping inview the rules in force in respect of the statutory reservation of seats under various categories of candidates.

**Age:** Preference will be given to those below 35 years of age.

### **Number of Seats: 12 +EWS**

Reservation will be applied as per the rule of Government of India (Reservation for PH — Persons having disability only in lower limbs without reverse limitations inmobility may be considered for this category).

**Affiliation:** West Bengal State University, Barasat, 24 Paraganas North, West Bengal (WBSU)

### Health:

Candidates are required to declare their health status in the application in case of pregnancy, in factious diseases, chronichealth problem so suffering from any psychiatric problem. If the candidate is unable to complete course requirement due to health problems then NIEPID reserves the right for termination from admission to M.EdSpl.Edn.(ID).

# **Duration of the Course: 2 years**

The Course/ programme will be of 4 Semesters (two years) with 2 semesters in each year. Each semester will be of 16-18 weeks; 2 weeks in summer and 2 weeks in inter semester break will also be utilized for covering the courses. In this way, the following operational weeks will be available for transacting the course:

Year 1-16-18 weeks for each of the two semesters + 2 weeks in summer

Year 2-16-18 weeks for each of the two semesters + 2 weeks in inter-semester breaks

No admission / readmission are to be made after the expiry of four weeks from the date of commencement of instruction. In case there are any court cases consequent on which the Convener of admissions is compelled to admit any candidate after the last date of admission, the admission (seat) of such a student be reserved for the subsequent year on supernumerary basis.

Supplementary or any other examination (except internal tests) shall be conducted during the instruction period of thesemester.

A candidate admitted to M.Ed Special Education (Intellectual Disability) course will forfeit seat and admission stands cancelledif;

He/she does not put in at least 40% of the attendance in Semester – I.

OR

He/she does not secure promotion to Semester-II within a maximum period of two academic years starting from the year of admission. The same system will be applicable for semester III and IV.

OR

He/she fails to fulfill all the requirements for the award of the degree as specified, within two academic years from the time of admission.

## **Award of Degree**

The M.Ed Special Education (Intellectual Disability) Degree in the Faculty of Education will be conferred on a candidate who has pursued a Regular Course of Study for two academic years as prescribed in the scheme of instruction and has passed all the examinations as prescribed in the scheme of examination. The degree will be issued by West Bengal State University.

# **Working Days and Attendance**

The programme will be conducted for at least 200 working days each year exclusive of the period of examination and admission. Physical presence in the institution of all the teachers and student teachers is necessary to ensure their availability for advice, guidance, dialogue and consultation as and when needed.

The minimum attendance of Student-Teachers shall have to be 80% for all course work, 90% for all practicum, and 100% for internship (10% attendance may be condoned by OU on health grounds).

In any semester of the M.Ed Special Education (ID) course, if a candidate fails to secure the minimum percentage of attendance, he/she shall not be eligible to appear in the examination of that semester and he/she shall have to enroll himself/herself to undergo afresh a Regular Course of Study of the corresponding semester in a subsequent academic session in order to become eligible to appear for the examination.

Attendance shall be reckoned from the date of commencement of instruction as per the almanac communicated by the College/University. However, in the case of late admitted candidates (but within the stipulated time), the attendance will be reckoned from the date of admission.

To enable the students to know their attendance, at the end of each month the concerned Heads of Departments shall display cumulative attendance for information

**MEDIUM OF INSTRUCTION**: The medium of instruction and examination is English.
