## **GENERAL TERMS & CONDITIONS:**

- (a) The applicant must be a citizen of India.
- (b) All applicants must fulfill the essential qualifications for the posts and other conditions stipulated in the notification as on the last date for receipt of applications.
- (c) The applicants serving in Government/Public Sector Undertakings/Autonomous Bodies must send their application THROUGH PROPER CHANNEL. This Institute employees are also required to submit that applications through proper channel.
- (d) The envelope containing the application should be superscribed as Application for the post of “Director, CRC, Davangere/Rajnandgaon/Nellore (as applicable)”. Applications that are received without such indication are liable to be rejected.
- (e) The filled in applications, in the prescribed format, along with the self-attested copies of certificates in support of educational qualifications, experience, caste, disability etc., should reach the Director, NIEPID, Manovikasnagar, Secunderabad-500009 by 07.08.2023. Applications received late/incomplete or not in prescribed format and not mentioning the name of the post will not be considered. No correspondence will be entertained in this regard.
- (f) Mere possessing the EQ will not entail any candidate a right to be considered eligible for the post. The final list of candidates called for interview/written test is based on the short-listing of candidates by a duly constituted Screening Committee. Only short-listed candidates will be communicated and no interim correspondence will be entertained.
- (g) The candidates should possess valid RCI/MCI registration as on the last date of receipt of application for the post.
- (h) Age, qualifications and experience will be reckoned as on the last date for receipt of applications. Legible copies of all certificates must be attached with the applications.
- (i) Demand Draft (non-refundable) of Rs.500/- drawn on any Nationalized Bank in favour of Director, NIEPID should be submitted along with the application. No fee is prescribed for candidates belonging to SC/ST/Women/PH/category. The candidate should clearly mention their name & post applied for on the back side of DD. The applications not accompanied by the required DD or the applications that are received without specifying the post applied for, will not be considered.
- (j) The Institute reserves right to accept or reject the application without assigning any reasons. Canvassing in any manner will disqualify from the selection process.
- (k) Any alterations/modifications to the notification/terms & conditions will be issued by way of addendum notification on the Institute’s website only.
- (l) For deputation, the pay & allowances are admissible as per Govt.norms on deputation. For contractual posts, fixed monthly consolidated remuneration will be paid as per the terms and conditions of the contract. No other allowances will be admissible.
- (m) All educational/professional/technical qualifications should be from a recognized Board/University.
- (n) The relevant essential experience requirement specified should be the experience acquired after obtaining the minimum educational qualifications required for the post.

- (o) The selection procedure for Group 'A' posts will be as per NIEPID norms.
- (p) For Deputation, the term initially for a period of 3 years and thereafter extendable after review of performance on years basis as per rules of Government of India governing deputation from time to time. For contractual appointments, term of appointment shall ordinarily be for an initial period not exceeding 3 years, extendable upto maximum of 5 years. Tenure of appointment on contract of retired employees should be maximum upto age of 65 years.
- (q) The selected candidates will be governed by the rules of NIEPID.
- (r) The reservation policy will be strictly followed as per GOI rules.
