## **Introduction:**

The National Institute for the Empowerment of Persons with Intellectual Disabilities (NIEPID) popularly known as NIMH, was established at Secunderabad, in the year 1984 as an autonomous body under the Ministry of Social Justice and Empowerment, Govt. of India. NIEPID values equal opportunities, protection of rights and full participation of the persons with Intellectual Disability. The institute developed indigenous service models based on research and development activities of the institute. These models have become the part of the curriculum of the professional courses. So far home based, community based, group parent training, early intervention services, special education models, and vocational models, have been developed, which are widely used in the country.

Independent living of persons with Intellectual Disability has long been a matter of debate between pragmatic and idealistic segments within the independent living movement emerged during the late 1960s and early 1970s. Some pragmatists question whether or not persons with intellectual disability are able to achieve that level of self-determination and self-direction which is the essence of living independently. Idealists, on the other hand, assert that the concept of independent living needs to be made available to all disabled individuals, including ones with intellectual disability. The independent living concept is just as important to persons with ID as it is to others with severe disabilities. They too want to be viewed by society as full human beings, to live as other members of society live, and to decide for themselves what to do with their lives.

Persons with Intellectual Disabilities constitute around 2.68 crore in our country as per the records of the Census 2011. The service providers in the area of intellectual disability are around 1200 in our country. According to the Census 2011, about 1.34 crores persons with disabilities are in the employable age of 15 to 59 years. In order to meet the requirements of the above mentioned lacunae a continuous interaction with the service providers is essential. This conference will be an initiative to provide a platform to discuss changing trends and develop models suitable to Indian conditions. The primary aim of the conference on “**Independent Living and Livelihood Programmes**” is to connect and network with members in the field of vocational rehabilitation of persons with intellectual disability.
